

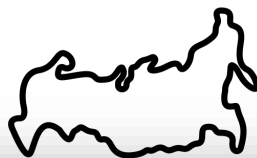

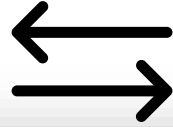

Customs clearance services

Customs clearance of goods within the Russian Federation

All commercial goods, crossing the borders of the Russian Federation, are subjected to customs clearance.

It includes:

- » **Release into free circulation** (for sale or use in the Russian Federation)
- » **Transit** (transportation through the territory of the Russian Federation without entering into circulation)
- » **Temporary import/export** (e.g. for exhibitions or repairs)
- » **Processing** (change of goods under customs control)

Who is able to register cargo?

- ✓ Cargo owner (independently)
- ✓ **Customs representative** – if the need for a professional occurs in complex cases

Customs clearance services

Company is an official customs representative (FCS license No. 0696/01)

1

Calculation and optimization of customs duties

- ✓ Assistance in reducing customs duties and taxes based on wright classification of goods according to HS code, exclusion of agency commissions in the customs value and correct registration of goods origin certificates.
- ✓ Minimization of risks of additional charges during audits.

2

Forwarding in TSW and customs warehouses

- ✓ Meeting the cargo, placing it in a temporary storage warehouse (TSW).
- ✓ Preparation of documents, safety control.
- ✓ Release of goods after completion of customs procedures.

Registration of special customs procedures

- ✓ Temporary import (for equipment, exhibitions, test consignments)
- ✓ Internal customs transit (ICT) – transportation through the Russian Federation without paying duties.
- ✓ ATA CARNET - simplified registration of temporary import (for example, for film equipment or exhibition samples).

4

Intellectual property management

- ✓ Registration of trademarks in the Customs Register of Intellectual Property Objects (CRIPO).
- ✓ Protection against counterfeiting: if customs finds a fake, the goods will be confiscated and the offender will be fined.

5

Preparation of documents

- ✓ Drawing up foreign trade contracts (FTC).
- ✓ Collection of a complete package for customs declaration (invoices, specifications, certificates).

6

Representation of interests in customs authorities

- ✓ Negotiating with customs authorities
- ✓ Submission of Customs Declaration Adjustments
- ✓ Decision-making in controversial situations (e.g.: challenging fines and decisions in court)
- ✓ Submission of complaints, etc.

7

Obtaining preliminary decisions on the classification of goods (HS codes)

- ✓ Determination of the exact code of the goods before import.
- ✓ Guarantee that customs will not change the duty rate after inspection.

Customs clearance services

Forwarding in TSW and customs warehouses



Temporary storage warehouse (TSW) - it's a customs control zone, where the cargo is stored before the registration is over.

What does the company do?

- >> **The reception of cargo** - checking condition, weighing, photographing.
- >> **Storage** – safe placement of cargo under the customs control.
- >> **Registration of documents** - preparation of declarations and acts.
- >> **Release of goods** - transfer to the owner after completion of all procedures.

Marking of goods on the territory of the Russian Federation

Marking of cargo before submitting declaration at a customs warehouse

Before the procedure of customs clearance all the goods, imported to Russia, must be marked in accordance with the requirements of Russian legislation.

"Chestny ZNAK" (Mandatory marking) The marking is a DataMatrix code that contains a unique product identifier.

Is required for certain categories of products:

- » Clothes and footwear
- » Medicines
- » Tobacco products
- » Alcohol
- » Tyres
- » Cameras and flash lamps, etc.

Additional requirements

- » For food products EAC mark (compliance with TR CU) is required
- » For electrical appliances certificates of conformity are necessary
- » For children's products - the "PCT" sign (Russian certification)

What are the company's responsibilities?

- ✓ Helps to register "Chestny ZNAK" codes if necessary
- ✓ Monitors compliance of products with technical regulations
